The Health Department implemented a new electronic health record system this year, after months of preparation. Customer service, staff efficiencies and management reporting capabilities have been enhanced, and the Department is positioned to benefit from federal "meaningful use" financial incentives.

Special funding was secured from the Michigan Department of Community Health to implement the nationally recognized Nurse Family Partnership program in Saginaw County. Focused on first-time pregnant women who are at risk for poor birth outcomes, public health nurses provide home visits, education and support during pregnancy and throughout children's first two years of life.

The County Board of Health and Board of Commissioners approved a new 2012-2013 Strategic Plan for the Department that articulates mission, vision and values and is guiding work over the next two years.

National Public Health Week was recognized with an all-staff training event on the application of quality improvement methodologies to public health practice. Expanding the use of continuous quality improvement (CQI) is a goal of the Department's new 2012-2013 Strategic Plan.

Based upon a social media pilot project, two Facebook pages were created, one for the Department and one for the Healthy Start Program, designed to provide outreach and education to the community utilizing web 2.0 technologies. A year-long media campaign was launched to promote public health messages and increase visibility of the Department and its services. Radio, billboard and bus advertising on the importance of immunizations was the initial focus, to be followed by emergency preparedness and food safety.

Eight pharmaceutical drop boxes were located throughout the County to collect unwanted over-thecounter and prescription medications that could otherwise find their way into ground or surface water. Funded through an Environmental Protection Agency grant to the Michigan Department of Agriculture and Rural Development, with supplemental funding from Great Lakes Restoration, 983 pounds of pharmaceuticals were collected in this first year of operation.

The Healthy Homes and Lead Hazard Control Program nurse completed 101 specialty assessments with eligible City of Saginaw residents to identify risks associated with environmental and safety hazards in the home and provided counseling and education on those risks.


The Environmental Health Services Division worked in conjunction with the Saginaw County Mosquito Abatement Commission to prevent West Nile and other arboviruses by reducing mosquito breeding in non-maintained private swimming pools. Forty-six such breeding sites were corrected in 2012 by either removing the pool or bringing the pool into proper operating condition. The Laboratory was awarded a competitive contract from the Michigan Department of Community Health to be the only regional public health laboratory besides the Michigan Bureau of Laboratories in Lansing to conduct sexually transmitted infection testing for other public health departments, family planning clinics and community health centers in the state.

The new WIC breastfeeding support program increased the breastfeeding initiation rate among WIC clients from 51% last year to 83%.












Number of Children Screened for Hearing





### INFANT MORTALITY






### OBESITY




No Leisure-Time Physical Activity, 2008-2010

Leading Causes of Death, 2010




### Behavorial Health



Current Smoker = The proportion of adults who reported that they had ever smoked at least 100 cigarettes in their life and that they smoke cigarettes now, either every day or on some days.


Former Smoker = The proportion of adults who reported that they had ever smoked at least 100 cigarettes in their life, but they do not smoke cigarettes now.




Heavy Drinking = The proportion of adults who reported consuming on average more than two alcoholic beverages per day for men and more than one alcoholic beverage per day for women.


